(Subject: "We request the EU Commission to actively support all Member States in introducing an Unconditional Basic Income that ensures every person's material existence and possibility for participation in society.")

Time planning and tasks to be fulfilled:

- b) Discussion about the start of our ECI January 2020, after the new Regulation for ECIs are in force (see **Att. 7**).
- c) find security manager/administrators (at min. 3); this has to be clarified, depending of our decission on item b) above.
- d) Create in the Kick-off meeting one day after the GA of UBIE the "Citizen's Committee"
- e) In order that the Commission provides the hosting of the OCSI (signature collection system) to the ECI Organisers free of charge, we have to come to a Hosting Agreement.
  HOSTING AGREEMENT between on one side, the European Union, represented by the European Commission, and, on the other side, the Citizens' Committee of the proposed citizens' initiative entitled Start Unconditional Basic Income; this has to be clarified, depending of our decission on item b) above, if this is necessary.

  - g) After the text in ENGLISH is accepted, the translation procedure can start (will need about 3 month); this has to be clarified, depending of our decission on item b) above, if this is

necessary. Concerning the text in ENGLISH see also **Att. 8** (feedback from ECAS).

- h) Beside the "official" Citizen's Committee (7 persons of 7 different countries), the "real Citizen's Committee" (the responsible persons of all Member states for our ECI), which can be regarded as the "Working Group" shall be established.
- Possible start of collecting signatures in the "12. International Basic Income Week" (end Sept. 2019) or January 2020, depending on our decission on item b) above.
